### **New York Closure**

The ISSC was advised today of the following biotoxic closure.

### Shellfish harvesters in the Town Southampton.

Due to elevated saxitoxin levels in mussel samples from Weesuck Creek in Shinnecock Bay, effective immediately on May 7, 2015, the Department of Environmental Conservation has implemented a temporary emergency closure of Weesuck Creek, in the Town of Southampton. This designation includes the taking of shellfish as well as carnivorous gastropods –whelks, conchs and moon snails.

On Wednesday, May 6, 2015, all that area of Meetinghouse and Terry Creeks (Flanders Bay), in the Town of Riverhead were also closed for the harvest of shellfish and carnivorous gastropods.

Barnes, Shellfisheries Section Head, Bureau of Marine Resources, Division of Fish, Wildlife & Marine Resources of the Department of Environmental Conservation, hereby designate the shellfish lands described below as **UNCERTIFIED** effective immediately on May 7, 2015, and continuing until a determination is made that marine biotoxins are no longer present at levels that may make shellfish and carnivorous gastropods hazardous for use as food.

Accordingly, it is unlawful to harvest shellfish and carnivorous gastropods from the following areas:

**Town of Southampton:** All that area of Shinnecock Bay, and its tributaries, lying westerly of the southbound lanes of the Ponquogue Bridge and easterly of the western (southbound) side of the Post Lane Bridge in Quogue.
